The Stewards, having received a report from the FIA Technical Delegate, having summoned and heard Mr. Shameer VARIWA (Team Principal), Mr. Jordi DURAN (Team Manager) and Mr. Matthew GREEN (Technical Director) in the presence of the FIA Technical Delegate, and having considered the matter, determine the following:

**Fact:** During final scrutineering, the rear wheel travels of the car No 206 were measured and reported over 350mm.

**Offence:** Breach of Art. 285-11.5 of Appendix J of FIA 2025 ISC.

**Decision:** - **Disqualification of Car No 206 from Baja España Aragón 2025, suspended** until the end of FIA 2025 World Rally-Raid Championship and FIA 2025 Baja Cups season, subject to no further breach of similar nature committed by the competitor during this period.

- **To impose a reprimand on Competitor of Car No 206.**

**Reason:** During the hearing the TD, Mr. Green admitted that before the event they did several measurements with a INC-CO Laser Distance Detector. They were wondering about varying results and attributed this to the interference of the changing sunlight.

During the final scrutineering measurements were done with three different measuring devices, which also showed fluctuations between 0 and 4 mm.

In principle, such deviations result in disqualification. However, as the fluctuations between the various measuring devices were too obvious, the Stewards decided to suspend this disqualification until the end of the FIA 2025 World Rally-Raid Championship and FIA 2025 Baja Cups seasons.

The decision is based on the FIA 2025 International Sporting Code Art. 11.9.1, Art. 11.9.3.a and Art. 11.9.3.f.


Competitors are reminded that they have the right to appeal certain decisions of the Stewards, in accordance with Article 15 of the FIA International Sporting Code and Chapter 4 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
